Approved Selectmen's Meeting Minutes

**Appointments:**

**7:45 Jean and Guy Daniello**

Above residents property borders Pickety Place and they are concerned that Pickety Place is operating outside their permit by being open nights and they believed they were serving wine.

The noise has been an issue, along with patrons of Pickety Place walking through their property and the intrusive night lights. They have spoken to the owners of Pickety Place about putting up a fence and the Daniello's thought they were in agreement about having a fence installed, however at this point nothing has been resolved. They are also concerned about security at night as people are wandering around in the dark and Jean Daniello has 2 young daughters.

Charles Moser suggested as far as security issues are concerned that she may want to speak with a lawyer.

Selectmen McGinnity told the Daniello's that the Board's prevue is permits and land use.

Selectmen McGinnity thanked them for coming in, said that the Board of Selectmen would look at their permits and the Board would write a letter to the owners Pickety Place, (if they found they were in violation of current permits,) asking them to come in and discuss the issues, review what their current operation is to see if they need to apply for further permits. Selectmen McGinnity stated that a fence between the properties is an issue that needs to be settled between the Daniello's and Pickety Place. He said the Board would inform the Daniello's when the Pickety Place owners are scheduled and that would be the time for them to make their opinions heard and also to discuss the fence as being part of any new permit. .

**8:00PM Melissa Liebermann**

Melissa Lieberman asked the Selectmen to consider a tax payment plan for property taxes. She is putting her house back on the market in the spring and hopes to sell it this coming year. Selectmen McGinnity said as we don't have your tax account available now that we can tentatively offer \$150 per month starting January 1, 2014 to be put against oldest year.
